## REFUND POLICY

It is the policy of CR HORSEBACK ADVENTURES that once an application has been made, a deposit sent and the student has been accepted by the school, the DEPOSIT AND TUITION FEES ARE NON-REFUNDABLE. The school will, however, accept a replacement student in the event you cancel, and if a replacement is found, either through your efforts or the school's, the school will transfer your deposit to a class the following year. It is also the policy of CR HORSEBACK ADVENTURES that there are NO REFUND OF DEPOSITS OR TUITION FEES if a student withdraws from the school, for any reason, prior to completion of the course.

CASH, MONEY ORDERS OR BANK CHECKS. NO PERSONAL CHECKS WILL BE ACCEPTED FOR THE FINAL PAYMENT UNLESS BALANCE IS PAID TWO (2) MONTHS BEFORE CLASS BEGINS.
